Installation/dismantling of Exhibits

Exhibitor Services

Parking facilities exhibitors. The trucks of the exhibition stand builders can be parked free of charge nearby.

Rules and Regulations

Demonstrations/Audio Visual Equipment All demonstrations shall be confined to the space allocated to each exhibitor. Activities which interfere with normal traffic flow or infringe on other exhibits are prohibited. The use of other than closed-sound systems will be permitted only with the prior approval of the Organizers.

Booth activities

The exhibitor is permitted to demonstrate the firm's equipment and to make informational presentations regarding the product line or service in the booth. However, other attention getting devices in the form of entertainment or amusement must be approved by the Congress Organisers prior to the start of the Congress.

Product Samples/Promotional Items

Exhibiting firms may distribute samples to the congress registrants. Advertising materials may only be distributed within the stand. Items other than product samples or educational materials should be tasteful and are subject to review by the Organizers.

Precaution

All hall entrances and exits, also emergency exits, passageways and accesses, staircases, etc., shall always be kept free and clear from any obstacles to their full width, and unlocked.

The following goods are not permitted in the Casino:

- Easily flammable or explosive substances, gases and/or dangerous goods including substances presenting danger or radiation.
- Goods which cause nuisance by their smell or otherwise, or appliances emitting objectionable noises or radiating disturbing light.
- Fixed lasers are permitted, free working lasers are not.

Furthermore, the fire protection installations, such as hand fire extinguishers, fire-alarm systems, hydrants, and the like, shall be visible and accessible at any time. All this at the discretion of the Organizers and/or fire service. In the event that an accident occurs as the result of a demonstration, the exhibitor concerned must immediately carry out all necessary measures and accept the responsibility for the settlement of all matters concerning the accident. No flammable substances or explosive bases may be brought into the exhibition area without prior permission from the Exhibition Organizers. Use of open flames is prohibited.

Security

General Guard service will be supplied by the Congress but no instance will guarantee the exhibitor against loss or theft of any kind. The safekeeping of the exhibitor's property is the responsibility of each exhibitor.

Damage to Facilities

No part of any exhibits, signs, posters, or displays can be nailed or attached to columns or walls or any parts of the Congress Center. Any damage to the Congress Center by an exhibitor shall be the financial responsibility of the exhibitor.

Insurance

It shall be the responsibility of each exhibitor to maintain such insurance against injury to person or theft, fire damage or loss of property in such amounts as the exhibitor shall deem adequate.
